4. First Aid Measures

General:	In all cases of doubt or when symptoms persist seek medical attention. Never give anything by mouth to an unconscious person.
On Inhalation:	Remove to fresh air, keep warm and at rest. If breathing is irregular or stopped give artificial respiration. Give nothing by mouth. If unconscious place in recovery position and seek medical advice.
On Eye Contact:	Contact lenses should be removed. Irrigate copiously with clean, fresh water for at least 10 minutes, holding the eyelids apart. Seek medical advice.
On Skin Contact:	Remove contaminated clothing. Wash skin thoroughly with proprietary nail enamel remover.
On Ingestion:	If accidentally swallowed obtain immediate medical attention. Keep at rest. Do NOT induce vomiting.

5. Fire Fighting Measures

Use carbon dioxide or dry powder. Do NOT use water.

6. Accidental Release Measures

Eliminate all sources of ignition and ventilate the area. Exclude all non-essential personnel. Avoid breathing vapours.

Contain the spillage with sand or other non-combustible absorbent material. Transfer the collected material into a suitable container for disposal.

Do not allow to enter drains or water courses.

7. Handling And Storage

Store in accordance with the conditions of the licence which is necessary under the Petroleum (Consolidation) Act. See HSE guidance note Storage of Flammable Liquids in Containers.

Store between 5 and 25 deg C in a dry, well ventilated place away from sources of heat, ignition and direct sunlight.

Containers which have been opened should be properly resealed and kept upright to prevent leakage.

Do not use in areas where potential sources of ignition exist. Electrical equipment should be protected to the appropriate standard. Use non-sparking tools and exclude sources of heat, sparks and flames.

Keep container tightly closed. Always keep in containers made of the same material as the supply container.

The product may charge electrostatically. Use earthing leads when transferring from one container to another.

Avoid inhaling vapour. Avoid contact with skin and eyes. Wear impervious gloves and safety glasses. Ensure good ventilation.

10. Stability And Reactivity

Avoid exposure to temperatures above 25 deg C.

When stored under conditions specified at paragraph 7 above, the material is stable and non-reactive.

11. Toxicological Information

There is no data available on the product itself.

Exposure to organic solvent vapours may result in adverse health effects such as irritation of the mucous membrane and respiratory system and adverse effects on the renal and central nervous systems.

Symptoms include headache, dizziness, muscular weakness, fatigue, drowsiness and in extreme cases unconsciousness.

Repeated or prolonged contact with the product may lead to removal of natural fats from the skin resulting in non-allergic contact dermatitis.

Splashes in eye may cause irritation.

12. Ecological Information
