2. COMPOSITION

Avocado Oil, French Lavender Essential Oil, Frankincense Essential Oil, Neroli Essential Oil.

3. HAZARDS IDENTIFICATION

Hazardous if ingested.

4. FIRST AID MEASURES

EYE CONTACT: Rinse immediately with plenty of water for 10 minutes at least. Contact a doctor if irritation persists.

INGESTION: Wash mouth out with water. Seek medical advice immediately.

5. FIRE FIGHTING MEASURES

Extinguish source of contamination if possible using CO₂, Foam or Dry Chemical extinguishers. DO NOT use water jet. Cool off all remaining closed containers with water once fire extinguished.

6. ACCIDENTAL RELEASE MEASURES

ENVIRONMENT PRECAUTIONS: Keep away from drains, surface and groundwater, and soil.

If a major spillage occurred into a watercourse, harm could be caused to aquatic birds and aquatic mammals. Therefore **immediate measures to contain the spill are necessary and removal of such creatures from the area.** Cleaning of these creatures would be the same

METHODS FOR CLEANING UP: Contain spilled material. Cover with an inert or non-combustible inorganic absorbent material, or sweep up and remove to an approved disposal container. Avoid naked flames or other sources of ignition.

7. HANDLING & STORAGE

PRECAUTIONS IN HANDLING: Apply good manufacturing practice and industrial hygiene practices, with proper ventilation. Do not eat drink or smoke while handling. Observe good personal hygiene.

STORAGE CONDITIONS: Ideally store in cool dry and ventilated area away from heat sources and protected from light in tightly closed original container. Keep air contact to a minimum.

8. EXPOSURE CONTROLS/PERSONAL PROTECTION

VENTILATION: Ensure good ventilation of working area.

9. PHYSICAL & CHEMICAL PROPERTIES

ODOUR: powerful and characteristic

APPEARANCE: mobile liquid

FLASH POINT (Degrees Celsius): >55

SOLUBILITY: Not soluble in water

10. STABILITY & REACTIVITY

REACTIVITY: It presents no significant reactivity hazards, by itself or in contact with water. Avoid contact with strong acids, alkali or oxidising agents.
