#### 4. First Aid Measures

#### 5. Fire Fighting Measures

#### 6. Accidental Release Measures

Eliminate all sources of ignition and ventilate the area. Exclude all non-essential personnel. Avoid breathing vapours.

Contain the spillage with sand or other non-combustible absorbent material. Transfer the collected material into a suitable container for disposal.

Do not allow to enter drains or water courses.

#### 7. Handling And Storage

Store in accordance with the conditions of the licence which is necessary under the Petroleum (Consolidation) Act. See HSE guidance note Storage of Flammable Liquids in Containers.

Store between 5 and 22 deg C in a dry, well ventilated place away from sources of heat, ignition and direct sunlight.
